Supply	Details
Twinpacks	Ideal for mixing without the entrapment of air.
Kits	The resin base and hardener are supplied in two separate containers, pre-weighed to facilitate accurate mixing for larger applications.
Bulk	The NP1044 system is formulated to prevent sedimentation on storage. However, storage at higher ambient temperatures (above 25°C for instance) or for long times, can cause some settlement. It is important that any sediment is redispersed into the bulk resin prior to using the resin. This can be done by stirring with a long spatula.
Shelf Life	The materials should be stored in the original unopened containers under cool dry conditions at temperatures between 10 and 25°C. The shelf life is one year. Opened containers should be resealed.
